The Migration EU eXpertise Initiative (MIEUX+) is a peer-to-peer experts' facility that has been supporting partner countries and regional organisations to better manage migration and mobility through the provision of rapid, tailor-made assistance upon request since 2009. It is a joint initiative funded by the European Union (EU) and implemented by the International Centre for Migration Policy Development (ICMPD) contributing to safe, orderly and regular migration. 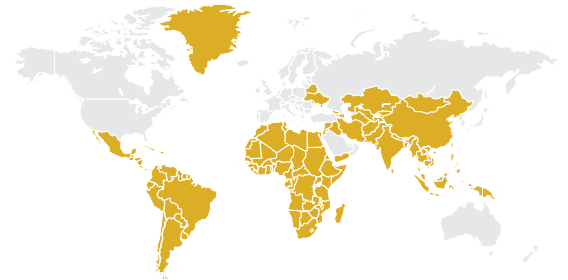

- ☐ Joint requests from multiple institutions are also possible

HOW DOES MIEUX+ WORK?

MIEUX+ offers short-term technical assistance through tailored activities that match the expertise required by the requesting partner country, deploying multi-country teams of migration experts originating mostly from within but also outside EU Member States. This facilitates the transfer of expertise through a peer-to-peer approach.

1. REQUEST



- ☐ Expression of interest via the MIEUX+ website
- ☐ Submission of an official request letter addressed to the MIEUX+ team or local EU Delegation (template is available)

2. PREPARATION



- ☐ Adaptation of request into Action Fiche
- ☐ Design and fine-tuning of activities targeting priority needs
- ☐ Approval by Project Steering Committee (European Commission and External Action Service)

3. IMPLEMENTATION



- ☐ Swift mobilisation of experts
- ☐ Capacity and knowledge development
- ☐ Ensuring ownership

4. RESULTS



- ☐ Results-based management
- ☐ Continuous monitoring and evaluation
- ☐ Promoting sustainability

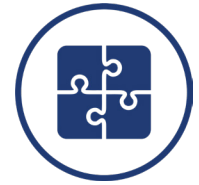
